OVER 400 PEOPLE TOOK PART IN OUR KICKOFF EVENT FOR THE INITIATIVE, AND RESTAURANTS REPORTED A SIGNIFICANT INCREASE IN PURCHASES OF THEIR PROMOTED DISH DURING THE WEEK. IN NOVEMBER WE PARTNERED WITH FOUR FOOD INFLUENCERS REPRESENTING A VARIETY OF CURRENT DIETARY PATTERNS TO TAKE PART IN OUR "NO MEAT NOVEMBER" CAMPAIGN BY CREATING AND PROMOTING A PLANT-BASED RECIPE TO THEIR AUDIENCES. THE PARTNER CONTENT HAD OVER 650,000 VIEWS COMBINED WITH OVER 45,000 INTERACTIONS.
